#### Horizontal

New Zealand requests Indonesia to increase its bound foreign equity participation limit to at least 70%.

- Please schedule commitments on <u>Installers/Servicers</u> (i.e. installers and servicers of machinery/equipment where such installation or servicing is a condition of the purchase of the machinery/equipment) for periods of stay not exceeding 3 months in any 12 month period.
- Please schedule commitments on <u>independent professionals</u> providing services on a fee or contractual basis without commercial presence for an initial stay of 1 year or for the duration of the contract.

#### National Treatment

- Reference to <u>expatriate charges</u>: clarify purpose and indicate to what extent the charges applied to foreigners differ from those applied to nationals.
- Requirement to hold a <u>work permit</u>: clarify criteria used in considering applications for work permits.
